ATTENDEE/MEMBERSHIP CONTACT INFORMATION
LICENSE AGREEMENT**

THIS AGREEMENT between Texas Affiliation of Affordable Housing Providers ("TAAHP" or "Licensor"), a Texas nonprofit corporation with 501(c)(6) status, consisting of membership organizations, and Sponsor ("Licensee"). In consideration of the covenants and terms contained herein, the parties hereby agree as follows:

1. Licensor hereby agrees to license to Licensee on a limited non-exclusive basis, the confidential and proprietary membership/attendee contact information ("MCI") of TAAHP.
2. MCI will be provided to Licensor within 60 days before the 2027 Texas Housing Conference (event) at which Licensor attends and fully pays for.
3. MCI will be used only for the specific referral contact for which they were ordered and for no other purpose, unless specifically authorized by TAAHP.
4. This MCI License shall be authorized for use by Licensor for a period of 60 days prior and up to 45 days after the 2027 Texas Housing Conference (event), at which time it shall automatically expire and Licensee agrees to refrain from further use.
5. TAAHP is not required to provide forwarding addresses for undeliverable mail or email.
6. Licensee's use of the MCI for telemarketing purposes is PROHIBITED.
7. Licensee may not include the proper name of Texas Affiliation of Affordable Housing Providers or the acronyms "TAAHP" in its marketing contact unless there is prior written authorization by TAAHP.
8. TAAHP is not responsible for claims made in Licensee's marketing to Members.
9. The Licensee agrees to furnish TAAHP with a copy or sample of printed material, literature and advertising material prior to fulfillment of order made in accordance with this agreement.
10. TAAHP retains the right to decline to license its MCI to any person or organization at its sole discretion.
11. TAAHP retains the right to decline to license its MCI to any organization intending to use MCI for the purpose of membership recruitment.
12. TAAHP retains the right to decline to license its MCI to any organization when the purpose is to promote an educational programming that competes with a similar TAAHP educational program or product.
13. Licensee's use of MCI will not imply TAAHP endorsement, directly or indirectly.
14. Licensee's use of MCI will not be used to communicate information that is false, deceptive, defamatory or misleading.
15. By signing this licensing agreement you understand this MCI License is for a period of 60 days prior and up to 45 days after the 2027 Texas Housing Conference (event) only. You agree to prevent duplication, transfer or reproduction of the MCI License, or information

thereof, in any form whatsoever, and to the other terms attached to this form. You agree to not use the MCI beyond the term of this License. To receive the MCI, this licensing agreement must be signed by an authorized individual from the purchasing organization.

16. The Licensee must pay TAAHP a fee, in advance for the use of the License based on the current fee. Licensee's cancellation prior to the event will result termination of this License Agreement and Licensee is not entitled to obtain MCI or use of MCI after such cancellation.

In the event Licensee violates any term of this License Agreement, Licensee agrees that Licensor shall be entitled to recover all costs, damages and attorney's fees occasioned by actions to enjoin violation of this license and in pursuing damages and any other relief. It is the specific intent of the parties that the courts in Travis County, Texas have exclusive jurisdiction, venue and authority under this License Agreement to award all available relief including each element of the foregoing. Licensee agrees to indemnify and hold Licensor harmless against any action arising out of or relating to use of Licensor's MCI.

By accepting the attendee list, Sponsor expressly agrees to be bound by the License Agreement and this Attendee List License Agreement.
